






Somerville Prevention welcomes the new Mayor of Somerville, Katjana Ballantyne!

Student Health Survey



2021 Results are in!

Middle & High School Students







Somerville HHS commissioned its annual Student Health Survey in May 2021 to get a sense of how middle & high school students were doing on a range of topics including mental health, substance use, etc., particularly related to COVID-19.


HHS worked with John Snow, Inc (JSI) & the Somerville Public Schools to craft & administer a virtual survey to hear from youth & inform programming needs.

Check out a few key data points on the next page!



- Over half of SHS students & almost one-fourth of SMS students reported that they struggled with their mental health most of the time or always during the coronavirus pandemic.
- While the majority of students did not experience any adverse financial or health-related affects of COVID-19, 20% of SHS students & 21% of SMS students had a family member or close friend who died.
- Current use of substances has decreased across years.
- Electronic bullying for SMS students increased significantly in 2021 while decreasing significantly for SHS students compared to prior years.
- School issues were the most common cause of overwhelming stress for SHS and SMS students.
 The greatest reported source of stress in school was keeping up with school work.

Cambridge Public Health Department







Somerville Prevention & the Cambridge Public Health Department continued successful opioid overdose prevention efforts with individuals experiencing homelessness and/or housing instability through the OD2A grant.

Through partnerships with Fenway
Health/ACCESS & the Somerville Homeless
Coalition, we have increased our ability to reach
individuals with trainings as well as now expand
to distribute fentanyl test strips, a harm
reduction technique to address the
dominant presence of fentanyl in
a wide variety of substances.

Opioid Overdose Prevention Grant

Since Oct. 2021:

- 40+ overdose prevention trainings
- S0+ doses of Narcan distributed
- 100 Fentanyl test strips distributed

Six City Tobacco Control Director, Bonny Carroll, has been hard at work, visiting tobacco licensees to provide education about tobacco/nicotine regulations.

On Nov. 18. 2021, the City of Somerville's Board of Health unanimously voted to adopt updated tobacco sales regulations, starting Feb. 1, 2021 to be even more closely aligned with the State's model regulations.

Check out some of the key highlights here!

Updated Somerville Tobacco Regulations!

- No permit renewal if three sales to person under 21
- Ban flavored rolling papers/flavor enhancements
- No smoking bars allowed
- All Somerville penalties to match MA
- Revised "Smoke Accessories" definition
